ENACTED by the House of
Assembly of Oyo State of Nigeria as
follows:

Short title.

1. This Law is cited as the Oyo State
Appropriation Law, 2019.

2. The sum of Two Hundred and
Eighty-Five Billion, One Hundred
and Fifty-One Million, Two Hundred
and Forty-Eight Thousand, One
Hundred and Ninety Naira, Forty-
Eight Kobo (₦285,151,248,190.48)
only shall be granted for Revenue
Estimates the Financing of 2019
appropriation from the sources set
out in the Schedule to this Law
during the year ending 31st day of
December, 2019.
