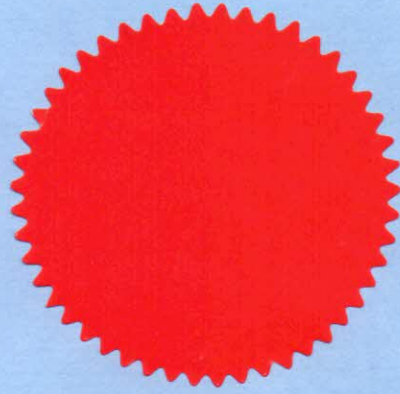
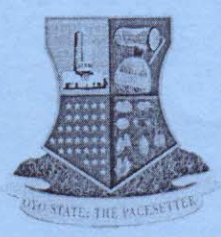

A LAW FOR THE REVIEW OF OYO STATE APPROPRIATION LAW, 2020 TO THE SUM OF ONE HUNDRED AND SEVENTY-FOUR BILLION, EIGHTY-SEVEN MILLION, FOUR HUNDRED AND FIFTY-THREE THOUSAND, TWO HUNDRED AND FORTY-ONE NAIRA AND FORTY-SIX KOBO (₦174,087,453,241.46) BEING ONE HUNDRED AND EIGHT BILLION, NINE HUNDRED AND FIVE MILLION, NINETY-NINE THOUSAND, SIX HUNDRED AND THIRTY-ONE NAIRA AND FORTY-SIX KOBO, (₦108,905,099,631.46) FOR THE RECURRENT EXPENDITURE AND SIXTY-FIVE BILLION, ONE HUNDRED AND EIGHTY-TWO MILLION, THREE HUNDRED AND FIFTY-THREE THOUSAND, SIX HUNDRED AND TEN NAIRA (₦65,182,353,610.00) FOR CAPITAL EXPENDITURE FOR THE SERVICES OF OYO STATE OF NIGERIA IN THE YEAR ENDING ON THE 31ST DAY OF DECEMBER, 2020

Date of Commencement. 1st of January, 2020

Enactment. **ENACTED** by the House of Assembly of Oyo State of Nigeria as follows:

Short title. 1. This Law is cited as the Oyo State Reviewed Appropriation Law, 2020.

Reviewed Appropriation of (₦108,905,099,631.46) Recurrent Expenditure First Schedule. 2. The reviewed sum of One Hundred and Eight Billion, Nine Hundred and Five Million, Ninety-Nine Thousand, Six Hundred and Thirty-One Naira and Forty-Six kobo (₦108,905,099,631.46) shall be appropriated from the Consolidated Revenue Fund during the year ending on the 31st day of December, 2020 for the services set out in the First Schedule to this Law.



3. The reviewed sum of Sixty-Five Billion, One Hundred and Eighty-Two Million, Three Hundred and Fifty-Three Thousand, Six Hundred and Ten Naira (₦65,182,353,610.00) shall be appropriated from the Consolidated Revenue Fund during the year ending on the 31st day of December, 2020 for the services set out in the Second Schedule of this Law.
